- Playground is near the end of time completion. A \$60,000 donation was given by the AHEPA
- Planning staffing and enrollment of both schools, joint admissions meetings given to look over applicationsIAPA Event: IAPA is a Greek organization who will be having their annual ball. Proceeds raised will go towards the Playground Project. Members from the school board and Habilitas Foundation will be present, as well as the director general.

5.7 Habilitas:

- Inclusive Playground: the campaign has achieved its fundraising goal to support this \$2.5 million project, including a \$500,000 endowment for maintenance and upgrade
 - Proceeds from the 2023 annual Valentine's Day Ball of the Montreal Chapter of AHEPA (American Hellenic Educational Progressive Association) were directed towards the play structures of the Inclusive Playground at Mackay Centre & Philip E. Layton schools. More than \$58,000 was raised this year!
 - Construction of the Inclusive Playground is set to re-commence soon as the snow melts. The final step will be pouring the rubber surface followed by installation of the accessible swings, merry-go-round and other structures. Assuming the work is finished in mid-June, Habilitas Foundation will plan a grand inauguration in the final days of the school year
 - Opération Enfant Soleil announced a gift of \$20,000 towards the purchase of the We-Go-Round – their largest gift to Habilitas Foundation to date.

Other projects that Habilitas Foundation has secured funding for in the school

o a NuStep cross-trainer (to promote aerobic capability and muscle strength through sessions with the rehab teams kinesiologist)

- Additional augmentative communication devices (tablets)
- ZotArtz: adaptive art tools so that children with disabilities can create huge, amazing art pieces

6.1 Approval of Safe School Action Plan:

- ➤ A few years ago, the Ministry of Education put into place a Safe School Action Plan for every school in an effort to reduce bullying in schools. This plan describes the Programs school putting into place to deter violence and bullying. Once it is approved by the Governing Board, it is sent to parents and is displayed on the school website.

6.2 Budget Building Consultation:

- ➤ The Governing Board was consulted on the Budget Building Process set forth by the EMSB and Agreed to the following points:
- 1. Assistive Technology Support: Increase the number of consultants servicing the school board as the current allocation is insufficient. Mackay/PEL would benefit from a 20%-40% allocation seeing as a good portion of our students use technology to communicate.
- 2.Professional Resources: more specifically an increase in the allocation of psychology services (one day) and speech and language services (one day).
- 3.Computer Technician Support: Increase in the number of technicians servicing schools directly. PEL would benefit from a 20% increase due to the high number of devices used by our student population.
- Regarding the Guiding Principles, Criteria, and Related Orientations:
